## Rental Terms and Conditions

Terms & Conditions - Please read the following Trailer Rental Terms and Conditions carefully.

Terms and Conditions & Rental Prices are subject to change without notice.

**1- Preparation:** Please allow yourself enough time prior to pick up for a complete walk through, instructions and set-up of the trailer, the check in and check out process can take up to 1 hour each.

**2- Returning:** There are no refunds for early returns. The trailer must be returned clean inside and out before returning. (See Cleaning Policy) If the trailer is not returned clean inside and out a minimum \$150.00 cleaning fee will be charged

**3- Rental Day:** The rental day is based on a 24 hour period. i.e. if you pick up the trailer on Thursday morning and return it on Monday morning it constitutes a 4 day rental.

**4- Pet policy:** Pets are not allowed in the trailer period! If evidence of a pet being in the trailer is found a minimum \$200 charge will be assessed upon return. **Please initial** \_\_\_\_\_

**5- Smoking policy: NO SMOKING is allowed in the trailer!!!!** If cigarette, cigar, pipe smoke, etc. is evident a \$300 charge will be assessed upon return. **Please initial** \_\_\_\_\_

**6- CLEANING POLICY:** We provide you with a vehicle that is in a clean condition when picked up. Our daily rental rates are calculated assuming you bring the vehicle back to us in a clean, re-rentable condition. The vehicle interior needs to be as clean as when you received it. This means no soil on the carpet, in the sinks, toilet, or shower, and all carpeted and fabric surfaces vacuumed. All of the counter-tops, appliances and cabinets should be wiped down with a non-abrasive household cleaner such as 409 or Cinch. Do not use abrasive cleaners such as Ajax or Soft Scrub since they will cause scratching that may require us to replace the components and subsequently charge you. **With that said, if you should choose to return the unit without cleaning the interior, you will be charged a minimum of \$150 for cleaning, depending on the how much cleaning needs done. The cleaning deposit collected does not limit the amount that will be charged to properly clean the RV trailer**

**7. Renter Damage:** If the trailer is returned with damage while the trailer is in possession of the renter, renter is responsible to pay all damage costs whether the renter was at fault or not or if the damage was caused by acts of nature (Wind, Rain, Hail, Fire, Flood etc.) If an accident does occur the renter is responsible for obtaining a police report, contacting the renter's insurance company and contacting who you rented from immediately. Renter(s) whose name appears on the contract are the only authorized drivers to tow the trailer.

**8. Insurance:** Renter must have proof of insurance coverage on their tow vehicle. Comprehensive insurance is required and can be purchased through our commercial renter's insurance policy. If Renter wants to provide their own comprehensive insurance, Renter must provide an insurance binder that shows full comprehensive coverage extending to the trailer. It is Renter's responsibility to contact their insurance company for the insurance binder and to give the insurance company the information on the trailer they are renting. Renter must call before their departure to acknowledge receipt of the insurance binder. The renter cannot leave with the rental trailer unless the insurance binder has been received and deemed acceptable.

**9. Early Returns/Extending Rental Days:** Renter is responsible for reading over the rental contract to ensure that all rental costs and rental dates are correct before they depart. If the renter wishes to extend their rental dates, renter must call for approval. There are NO refunds for early returns. If renter does not return on their scheduled date and has not called for approval to extend, renter will be charged \$ 200.00 plus additional rental day (s). Please remember that the trailer may be reserved following your dates and will need to be returned to allow the next reservation to take possession.

**10. Parking/Traffic Violation:** Renter is responsible for reporting and payment of any and all parking/traffic violations at rental return. Non-reporting of such violations breaches the rental contract and may result in an administrative charge of up to \$ 150.00 in addition to the fines.

**11. Pick up and Drop off times:** No refunds will be given for late pick-ups. This is a side business for UT RV Rental so please be prompt when picking up or returning.

**12- WAIVER OF LIABILITY:** In consideration of being allowed to rent a trailer the undersigned expressly waives and releases its owner, its administrators, directors, agents, officers, and employees, from any and all causes of action or claims whatsoever, of any kind or nature, arising from, or in any manner related to, customer's rental and use of the camper. This Waiver and release shall insure to the benefit of the assigns or successors of owner and shall be binding upon the heirs or successors of customer. Customer specifically understands that use of the trailer is at customer's own and sole risk. Customer specifically acknowledges his experience and capabilities and believes he is qualified to use and operate the trailer. Customer fully understands that use of the camper involves risks and dangers and may result in serious bodily injury. Customer understands that his/her own actions, or inactions, the actions or inaction of others or the negligence of the releases may cause such risk and dangers. With full knowledge, the customer fully accepts and assumes all such risks and all responsibility for losses, costs, and damages incurred as a result of his use of the trailer, of any kind or nature whatsoever. Customer further agrees that if, despite the release, he or anyone on his behalf makes a claim against any of the releases named herein, customer will indemnify, save and hold harmless each of the releases from any litigation expenses, attorney's fee, loss liability, damage or cost any may incur as a result of any such claim. Customer acknowledges that he has read this release, fully understands its terms, understands that he has given up substantial rights by signing it, and has signed it freely and without any inducement or assurance of any nature, and intends same to be a complete and unconditional release of all liability to the greatest extent allowed by the law of the state in which such activity is conducted and further, agrees that if any portion of this release is held to be invalid that the balance, notwithstanding, shall continue in full force and effect.

**13. Payment:** To secure a reservation, the renter agrees to a \$100 nonrefundable deposit. The full balance of the agreed upon rental price is due at the time of pick up in the form of cash or credit card. If the reservation is cancelled within 30 days of departure, you will be responsible for 50% of the rental price if no subsequent renter is found. You will be responsible for the full rental amount if cancellation is made within 7 days of departure and no subsequent renter is found. You authorize these rental amounts to be collected via credit card at the time of cancellation. A mandatory \$500 Refundable Security Deposit and a \$150 cleaning deposit is to be paid in cash or authorized on Credit card at the time of pick up. It will be refunded to you upon return of clean, undamaged re-rentable unit.

**14- Unforeseen conditions:** The renter understands that efforts will be made to ensure that everything is working in the trailer, but things can and will go wrong that may impact your use & enjoyment. If something goes wrong with the trailer, every effort will be made to correct the problem. If the problem presents an unsatisfactory experience for the renter, the renter may return the trailer early and receive a refund for the unused rental period. However, a refund for the portion of the rental period that was used is not permitted.
